18.18 DISCLOSABLE PECUNIARY INTERESTS

19.18 PROPOSED RESIDENTIAL DEVELOPMENT LAND AT THE CROSS, WEST FELTON

Following the earlier discussion in Agenda Item 16.18 *Public Participation Session,* Councillor Chris Jones proceeded to leave the room due to his disclosable pecuniary interest and the Clerk reported the 3 quotes received in order to obtain legal advice from a specialist Planning Solicitor as to whether we have a case going forward. It was pretty clear that the budget of £1000 set would soon be exceeded and in light of this, Councillor Alison Ollier proposed that we do not proceed with obtaining legal advice and Councillor David Curtis seconded. A vote was taken with a unanimous outcome NOT to proceed in engaging a solicitor. Council then considered comments for submission to Shropshire Council following the Planning Committee's decision to allow further consultation with West Felton Parish Council. The comments were then **AGREED** and the Clerk will submit them to the Planning Department by 30th January.

20.18 TRANSPARENCY CODE FUNDING 2018-19

The Clerk explained that we can only apply for the Clerk's time to update and maintain the Parish Council's website which is estimated at 2 hours per month. Council approved and **AGREED** the application form for submission before the deadline date of 9th February 2018.
