MINUTES of a meeting of WEST FELTON PARISH COUNCIL held on TUESDAY 8TH AUGUST 2017 at 7.30p.m in West Felton Methodist Church Hall.

With approval of the meeting, the Chairman brought forward agenda items 53.17a)i) and 53.17c) to the Public Participation Session.

46.17 PUBLIC PARTICIPATION SESSION

Agenda Item 53.17a)i) – Planning Application ref: 17/02865/FUL was discussed at length with participation from residents of the parish. There were concerns raised regarding the increased traffic on the lane used to access the site, drainage and water pressure for residents. It was agreed that an extension of time for comments should be requested from the Planning Department at Shropshire Council and that the Clerk invite Planning Agents, Forge Property Consultants, along to the next parish meeting to answer any further questions and respond to concerns raised by the Council and residents.

Agenda Item 53.17c) – Planning Correspondence regarding 16/05336/REM. There was much discussion with participation from Resident Chris Jones regarding the reserved matters for the potential development for the land at The Cross. It was agreed a strongly worded letter should be put together to the leader of Shropshire Council following on from our previous letter dated 21st July 2017, outlining the Council's anger at how this has been handled by the Planning Department at Shropshire Council. Stated in the letter will be that we consider that the deadline for the first batch of reserved matters had been exceeded by at least 10 weeks, and thus the application had surely timed out and should be refused immediately.

54.17 'WE DON'T BUY CRIME PROTECTED BY SMARTWATER'

The Smartwater initiative was discussed again and after a show of hands, seven Councillors were for undertaking the scheme and two were against and therefore it was AGREED that the matter should be

taken forward. The Clerk is to contact Rachael Oakley at SmartWater Technology Ltd to ask some further questions regarding how it is to be rolled out and whether volunteers will be required.

55.17 HIGHWAYS

a) Community Speed Watch – The clerk reported that having joined forces with Ruyton, we now have enough volunteers to take the Community Speed Watch forward. The clerk will liaise with Sue Hackett, clerk of Ruyton, who is already liaising with West Mercia Police regarding possible dates for the training to take place.

56.17 PARISH MATTERS

- a) Greenfingers Contract There were further concerns raised regarding the moss in the gravel on the burial ground car park. Clerk agreed to contact Greenfingers regarding this matter.
- b) Burial Ground Maintenance The Clerk was asked to contact Greenfingers for a quote to weed kill and have the soil stack cleared and fresh soil replaced. She was also asked to make contact with Scottish Power regarding the transformer and whether it is still live and in use. If not, she will ask for this along with two poles to be removed from the burial ground.
- c) Annual Inspection of Playground and apparatus and necessary repairs Kay Kynaston agreed to meet with Martin Mee from Shropshire Council in order for him to go through his concerns.
- d) Goalposts for playing field Kay Kynaston reported that she had arranged for Ringway to mark out the football pitch on the playing field. The goalposts can then be fitted, however the Clerk reported that according to 'Itsagoal', there could be a three week wait.
- e) Obstructed footpaths It was agreed that Shropshire Council should be contacted if there are
 any issues regarding obstructed footpaths as they have responsibility to make sure footpaths
 remain accessible. They will require specific addresses as to where the problems of overgrown
 hedges are occurring.

a) Possible hearing aid solutions were discussed for future parish meetings including installing a hearing loop or the possibility of purchasing a Conference Discussion System. The Clerk was asked to gather more information regarding the Conference Discussion System as this appeared to be the most favoured option.
