- a) Burial Ground Maintenance The Clerk reported that Cllr Barnes had been investigating solutions to the drainage issues at the burial ground and had been asked if we could supply a plan or survey of the site. As this was not available, enquiries are to be made about possible low cost practical solutions to the problem.
- b) Playing Field Maintenance The Clerk reported that the contractor has ordered all equipment and parts and expects delivery in early January. The Clerk was asked to obtain a copy of the s106 Alma Close Agreement in order to explore the possibility of amending the Agreement in order to use those funds to pay for the replacement equipment and repairs.
- c) Streetlighting It was reported that the replacement LED lanterns had been ordered by the contractor with delivery expected in January and fitting scheduled for February 2019. A quote and recommendations for installation of three LED streetlights at Queens Head was considered and it was RESOLVED to proceed with the quote and recommendations.
- **d) Speeding** It was **RESOLVED** not to proceed with the use of wheelie bin speed limit stickers due to distribution issues.
